### Liability Waiver Release and Indemnity Agreement

# This document will affect your legal rights and liabilities \*Please read carefully before signing\*

To: Northwest Women's Surf Camps, LLC,

I am aware that surfing and bodyboarding involves many inherent RISKS, DANGERS and HAZARDS, including not limited to, the use and operation of surfboards and bodyboards, impact of collision with surfboards of any thereof including the fins and other attachments; skin irritations or abrasions caused by the use of wetsuits; ear infections caused by the water; impact to the beachhead, or, as the case may be, the ocean floor; severe weather conditions; my ability to swim in dangerous ocean conditions, as the case may be; extreme water and air temperatures; the prevailing condition of the surf; undertow and tide; the possible existence of dangerous rocks, reefs, driftwood, logs, floating objects, sea mammals and other hazards and obstructions, whether marked or unmarked in the area chosen by you to conduct surfing and bodyboarding camps; impact of collision with swimmers, bodyboarders or other surfers or their surfboards, whether or not caused by the negligence of such swimmers, bodyboarders or surfers; dangers involved in traveling to the surfing area including possible transportation provided by Northwest Women's Surf Camps and hazards involved in reaching the shoreline by foot; negligence on the part of Northwest Women's Surf Camps or its staff. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting from such risks, dangers, and hazards. In consideration of Northwest Women's Surf Camps agreeing to provide me with possible transportation, surfing, bodyboarding and yoga instruction, supervision and training (which are together referred to as the "Surfing Services") as part of the camp I have registered for with Northwest Women's Surf Camps.

#### I hereby agree as follows:

- 1. TO ASSUME AND ACCEPT ALL RISKS, DANGERS AND HAZARDS in connection with my use of the Surfing Services.
- 2. TO WAIVE ANY AND ALL CLAIMS that I may have against Northwest Women's Surf Camps, their director, employees and representatives (all of whom are collectively referred to as "Northwest Women's Surf Camps");
- 3. TO RELEASE Northwest Women's Surf Camps from any and all liability for any loss, damage, injury or expense that I, or my next of kin, may suffer or incur as a result of my use of the Surfing Services due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF NORTHWEST WOMEN'S SURF CAMPS;
- 4. TO HOLD HARMLESS AND INDEMNIFY NORTHWEST WOMEN'S SURF CAMPS from any and all liability for property damage, personal injury or death suffered by myself or by a third party as a result of my use of the Surfing Services;
- 5. THAT THIS RELEASE AND INDEMNITY AGREEMENT shall be effective and binding on my heirs, next of kin, executors, administrators, and assigns, in the event of my death;

- 6. TO OBEY all warnings, safety instructions, cautions and other notices provided to me by Northwest Women's Surf Camps;
- 7. Northwest Women's Surf Camps Director has the right to refuse to provide me with Surfing Services if, in the opinion of Northwest Women's Surf Camps, my swimming abilities, health or the prevailing weather conditions could render it dangerous or unsafe for me to use such Surfing Services.

I have read and understand this Release and Indemnity Agreement prior to signing it and am aware that by signing this document, I am affecting the legal rights and liabilities of myself, my heirs, next of kin, executors, administrators and assigns in relation to Northwest Women's Surf Camps.
